Our field is looking great for early spring. The flooding hasn't hurt us. Ted Ede, Bob Fregault and I took a took a stroll around the air field. We looked at the impromptu pond we have as result of the heavy rains. We also looked at the areas around our field. The trees we had cut down two years ago gave us a lot more room to fly. But there is more work to do. The trees and bushes along the brook are starting to infringe on our airspace and making recovery of errant aircraft more challenging. We also have felled trees in the brook which need to be removed to meet the expectations of the Merrimack Town Counsel.

All of this work will take some time. In the past, we have attempted to accomplish the upkeep of the field and all of our other possessions with two field maintenance days. After walking the field and talking to the other officers, it is apparent two annual sessions won't make everything happen that we need to complete. To manage all of this, the officers decided we need to set up multiple field maintenance days. Our plan is to hold one field maintenance day each month.

The FAA requires that all RC clubs maintain a list of FAA Registration Numbers for each club member.

Please follow the instructions below to obtain an FAA UAS registration number:


- 1) Go to https://www.faa.gov/uas/getting_started/register_drone
- 2) Once at the FAA page, click the "Register your drone at FAADroneZone" link
- * Once you register your drone, you will receive an FAA registration certificate. You must have your registration certificate (either a paper copy or digital copy) in your possession when you fly.
- * The FAA requires that you label all drones with your registration number before you fly them.

Minutes to Club Meeting 3/06/2024

Attending Officers:

Tim Sowder, President Johnny Yaz, Vice-President Ken Donahue, Field Marshall Carl Andersen, Safety Officer Bob Fregault, Treasurer



Meeting was called to order at 7:35 PM.

A - President's Comments:

- April Meeting: "Show & Tell" month and discussion of this year's budget.
- Newsletter: Newsletter was unanimously approved and accepted by show of hands.

By-Law Amendment:

- Tim Sowder read the proposed By-Law amendment submitted by Bob LaCroix to the 16 club members in attendance. The proposed amendment called for the removal of the 4-year term limit on officers' positions. The proposal would make the term of office an annual election but the incumbent officer could run for any number of terms.
- After much discussion, the amendment passed by hand vote with 12 members in favor of the proposal, 3 members opposed, and 1 member abstaining.

The Secretary's Report (...continued)

Training Program:

- Zach provided a syllabus to standardize new pilot training, including pre-flight check list, pre-flight inspection, and takeoff check list.
- SNHFE lacks a structured approach to training new flyers; each instructor has their preferred way of training new pilots.
- With modern PNP and BNF aircraft there is less attention to how to prep an aircraft as opposed to nitro or gas aircraft.
- A formal structured training syllabus would allow students to progress each week regardless of which instructor is helping the student that week. Tracking the student's progress is the important thing.
- Instructors need to get together to develop the standardized training syllabus.
- Tim also mentioned the need for more instructors.

Winter Carnival was a big success thanks to Bob LaCroix, Joe Marone, and Russell Richards. We received interest from 5 new individuals who came to our field the following Sunday.

Field Improvements – Things we need to do:

- Additional trees to be cut
- Tree debris in the brook needs to be removed
- Flight stands need maintenance.
- Tim proposed having monthly field improvement days instead of twice-a-year cleanup days.

Control line Flying:

- Need to install a permanent pilot circle for control line flying. Tim to coordinate a design with the control line pilots team.
- Control line flying would have a window of time to fly so as to not interfere with RC flying.
- Best control line flying seems to be early morning (7 7:30) while the air is still and cool. Would have to be electric planes since nitro would violate club rules about flying nitro before 10 AM.

Annual Operating Budget – Things to consider:

- Could use 3 new flight stands
- Need to enclose the charging station to protect against weather
- Foam insulation on flight stands needs to be replaced
- Need a new cabinet or racking system to protect training aircraft while in the container.
- Container doors on mower container are difficult to open and need adjustment/repair
- Power to cameras needs to looked at
- Should consider adding 2 additional solar panels and 2 additional batteries to the charging station.
- Need to fill in the puddle in the parking area. A system of GTex and stone was suggested as a possible solution. John Spitz proposed an "egg carton" type base that can support car traffic. John to investigate.

Club Safety Rules



The Southern New Hampshire Flying Eagles RC Club is an AMA-sponsored club and operates according to AMA Safety Rules. In addition, the following safety rules and practices are to be followed when flying at our flying site. The intention of these club safety rules is

- a) to maintain the highest level of personal safety for all members, guests, and spectators, and
- b) to keep our aircraft in good flying condition and to prevent unnecessary damage to them.

Please read and familiarize yourself with the AMA Safety Program that is online on the AMA web site.

General

- 1. All aircraft must be marked with your AMA member ID and FAA ID on an exterior surface and must be easily readable. Aircraft weighing less than .55 lbs. do not need the FAA ID.
- 2. No take-offs or landings from the pit area.
- 3. No more than 4 (four) aircraft in the air at any one time. (Helicopter hover area doesn't apply)
- 4. Only SNH Flying Eagles designated instructors shall give or supervise flight instruction at the SNH Flying Eagle's field.
- 5. All pilots are required to fly from designated areas on the flight line or hover area.
- 6. These Safety Rules may be amended by majority vote of the Officers.

Personal Safety

- 1. All flying must take place in front of the safety fence and the indefinite extensions of this fence in both directions. This means no flying over or behind the pit area, spectator area, or parking area.
- 2. Never taxi your aircraft in the pit area.
- 3. Never walk from the pit area to the flight line carrying an aircraft running at full throttle. (Exception: engines with no throttle)
- 4. If possible, program an easily accessible switch to kill your throttle until you are read to taxi or take off.
- 5. Announce your intension to take off and the direction you intend to take off in.
- 6. When going onto the field to retrieve an aircraft, announce your intentions loudly to all pilots on the flight line.
- 7. All club members will adhere to the safety guidelines as outlined in the AMA safety manual.

AMA Safety Rules



Academy of Model Aeronautics National Model Aircraft Safety Code

Effective January 1, 2018

A model aircraft is a non-human-carrying device capable of sustained flight within visual line of sight of the pilot or spotter(s). It may not exceed limitations of this code and is intended exclusively for sport, recreation, education and/or competition. All model flights must be conducted in accordance with this safety code and related AMA guidelines, any additional rules specific to the flying site, as well as all applicable laws and regulations.

As an AMA member I agree:

- I will not fly a model aircraft in a careless or reckless manner.
- I will not interfere with and will yield the right of way to all human-carrying aircraft using AMA's See and Avoid Guidance and a spotter when appropriate.
- I will not operate any model aircraft while I am under the influence of alcohol or any drug that could adversely affect my ability to safely control the model.
- I will avoid flying directly over unprotected people, moving vehicles, and occupied structures.
- I will fly Free Flight (FF) and Control Line (CL) models in compliance with AMA's safety programming.
- I will maintain visual contact of an RC model aircraft without enhancement other than corrective lenses prescribed to me. When using an advanced flight system, such as an autopilot, or flying First-Person View (FPV), I will comply with AMA's Advanced Flight System programming.
- I will only fly models weighing more than 55 pounds, including fuel, if certified through AMA's Large Model Airplane Program.
- I will only fly a turbine-powered model aircraft in compliance with AMA's Gas Turbine Program.
- I will not fly a powered model outdoors closer than 25 feet to any individual, except for myself or my helper(s) located at the flight line, unless I am taking off and landing, or as otherwise provided in AMA's Competition Regulation.
- I will use an established safety line to separate all model aircraft operations from spectators and bystanders.



Drobysh-Patterson RC Field

The Merrimack field is less than one mile from exit 11 off the Everett Turnpike. After leaving the highway, head east and go straight through all the lights and down the little hill. Spectators are encouraged to park in one of the parking lots and walk to the field. Pilots should turn left at the foot of the hill, and then make a hairpin right turn on the dirt road that goes under the railroad bridge. The field entrance is on the left as soon as you pass under the railroad tracks.
